

Power of Attorney and Authorization

(I, the electronic registrant or subscriber to TAMM Network for Volunteering by means of my personal data, including name, date of birth, nationality, etc, which I have registered here and on all TAMM Network for Volunteering accounts and websites, do hereby affirm that I am liable for the accuracy of this data, and that I, the user of TAMM Network for Volunteering website or social media pages, and the registrant on its website, have hereby, in law and legislation, given full authority to TAMM Network for Volunteering to correct my personal data registered with it and collect such data from my registration with them or with other parties, amend this data, and use it in part or whole by providing, sharing, or presenting it to other parties, including on the Internet and its websites, pages, accounts, social media, and media, whether for public or private use. This shall hereby also include my non-personal information about my personal computer or mobile device, including my IP, GPS data, device drivers, settings, internet browser, language, and other information, all in part or whole and without exception, according to the needs of TAMM Network for Volunteering, without need for my approval or to inform me of this use. The Network is also permitted to omit some or all of the data in any one kind or all kinds, as well as to terminate, suspend, or block my registration or subscription, no matter what type, any time it deems fit based on its judgment, and without need to inform me or for my approval. I have also authorized TAMM Network for Volunteering to process my personal data, whether necessary or not, as well as making the amendments they deem fit according to their personal discretion, without need for my approval. The Network shall also act in my stead to approve on my behalf and seek information about me from its own or from other parties, whether before or after the processing of my personal data, without need to inform me, whether the data is mine, theirs, or the processing parties, and it shall act on my behalf in seeking or providing information about me from itself or other parties. This includes TAMM Network for Volunteering data or any other party handling data processing for TAMM Network for Volunteering or its use by the Network or that other party, as well as the purposes for which TAMM Network for Volunteering or any other party wishes to process the data for itself or for myself. This shall also include a detailed and accurate description of the processing activities and degree of data sharing for legal purposes, as well as any other information deemed necessary and required to meet the data processing requirements, including in the case of any violations of Article 13 of Law Number 13 for the Year 2016. TAMM Network for Volunteering is also authorized to store all my data that it deems fit. TAMM Network for Volunteering or whomever it authorizes may also send me electronic transmissions for direct marketing or any SMS messages on my mobile device. I have also authorized the Network in all matters not mentioned herein and in all that has been mentioned to act on my behalf in the implementation

of Law Number 13 for the Year 2016, regarding the protection of personal data privacy, including my rights of practice, information, or notification, and to give or seek information about me from itself or other parties. I consider my agreement to register or subscribe to the Network an electronic signature on this power of attorney and the Network's privacy policy, and it is also serves as my consent to transact with the Network and a notification of my waiver of all rights or compensations related to errors that may arise because or in consequence of my registration, subscription, or transactions with TAMM Network for Volunteering in any of its accounts, platforms, websites, or social media.)
